# Directions to the Alameda County Dept. Adult & Aging Conference Rooms: <u>Maxwell Park & Sobrante Park</u>

The Maxwell Park and Sobrante Park Conference Rooms are located at the Eastmont Town Center: <u>6955 Foothill Blvd, Suite 143, Oakland 94605</u>, within the Social Services Agency, Adult & Aging Services Lobby on the 1<sup>st</sup> floor. The Lobby is accessible through the entrances shown below. For the quickest access, it is best to enter through Entrance C.

### Entrance C – Lower level next to Center for Elders Independence & Social Services Agency, Self-Sufficiency Center 73<sup>rd</sup> Ave & Garfield):



**Parking:** Turn into parking lot, go straight alongside the Police Substation on the right. Turn right to enter the lower parking structure. Proceed past the stop sign. Park in the designated areas, between C1 - C4 on the left.

**Directions to Lobby:** Enter mall and continue straight. Turn right just before the stairs. Enter Suite 143, on the right. **Sobrante Park:** directly across the open lobby, first door on the right. **Maxwell Park:** to the left of the service windows, make a left, doors are on the left across from bathrooms.

### Entrance E – Upper level next to Oakland Police Station (Foothill Blvd):



**Parking:** Enter the upper parking structure by the Eastmont Wellness Center (blue awning). Turn left at the stop sign (towards McDonald's). Park in the designated area, just past the stop sign on the right.

**Directions to Lobby:** Enter mall and continue straight. Take the stairs down to the first floor and turn left. Enter Suite 143, across from stairs. **Sobrante Park:** directly across the open lobby, first door on the right. **Maxwell Park:** to the left of the service windows, make a left, doors are on the left across from bathrooms.

**Accessibility Access:** Enter mall, make an immediate left and follow the corridor to the elevator. Take the elevator to the 1st floor and exit to the right. At the end of the short hallway, turn left. Proceed straight. Turn right just before the stairs. Enter Suite 143 on the right.

## Entrance D – Lower-level next to Alameda County Behavioral Health Care (Church St):



**Parking:** Turn into the parking lot, the lower parking structure is just to the left of Miley Garden Apartments. Park in the designated areas, between D1 - D3.

**Directions to Lobby:** Enter mall and proceed straight towards the back of the mall. Continue past the Self Sufficiency Center on the left. Enter Suite 143 on the left, across from stairs. **Sobrante Park:** directly across the open lobby, first door on the right. **Maxwell Park:** to the left of the service windows, make a left, doors are on the left across from bathrooms.

### Entrance A – Lower-level near Gazzali's Supermarket (Bancroft St):



**Parking:** Enter parking lot between Auto Zone and Burger King and proceed straight towards the stop sign. Park in the areas either to the left or right of the stop sign. **Sobrante Park:** directly across the open lobby, first door on the right. **Maxwell Park:** to the left of the service windows, make a left, doors are on the left across from bathrooms.

**Directions to Lobby**: Enter mall and proceed through the corridor past the glass doors. Upon passing the Café, turn right and walk down the mall towards the stairs. Enter Suite 143 on the left, across from stairs.
